SPECIFIC EXPERIENCE IN EVALUATION OF OIL AND GAS PROPERTIES (See By-Laws, Article III, Sections 1 and 4)

A Member is required to have ten years of experience in the evaluation of oil and gas properties. Five years responsible petroleum engineering experience, or five years teaching petroleum engineering courses in a college or university accredited by the Accreditation Board of Engineers and Technology (ABET) may be substituted for five years of experience in the evaluation of oil and gas properties. Experience in the evaluation of oil and gas properties shall mean that the principal employment on a consistent basis regularly involves the evaluation of oil and gas properties. "Evaluation" of oil and gas properties includes, but is not limited to, the responsible determination of petroleum reserve/resources estimates, the responsible determination of production forecasts, and the responsible inclusion of the economic impacts of reserves/resources and production estimates.

An Associate Member shall be required to demonstrate at least five years of experience in the evaluation of oil and gas properties (rather than the ten years required for Members), one half of which time (2-1/2 years) can be satisfied by the substitution of either 2-1/2 years of responsible petroleum engineering practice or 2-1/2 years of teaching petroleum engineering courses in an accredited college or university. Please provide details about projects that span the course of your career so the Qualifications Committee can better appraise your overall evaluation experience.

As part of each application, the SPEE requires a statement describing and illustrating the <u>specific</u> evaluation experience which qualifies each applicant to become a Member of SPEE. One method that is strongly recommended for this statement is to provide a series of specific project descriptions which span the applicants tenure of evaluation of oil and gas properties. General statements and broad descriptions are not helpful. Please take the time to provide as much information as possible. Indicate if the experience was "hands-on" vs. supervisory, and note the areas of expertise (i.e., petrophysical, reserves, economics, etc.) which are emphasized by each "Project". Given that this statement is intended to illustrate at least 10 years of oil and gas evaluation experience, the Executive Committee recommends that at least 4 different projects be described.

Note that the written project descriptions described herein are intended to be primarily for Qualifications Committee and Executive Committee use in evaluating the applicant's eligibility under Article III of the SPEE By-Laws. These project descriptions may also be used by SPEE Sponsors who have known the applicant for at least one year and intend for the descriptions to serve as a refresher of applicant's experience. However, these project descriptions <u>are not intended</u> to be the sole basis upon which SPEE Sponsors assess qualifications for SPEE membership using the Interview Method. In this case, substantially more review by the sponsor is expected.

Instructions to Applicants

The Executive Committee is pleased that you have made the decision to apply for SPEE membership. In order that we may be able to assess your qualifications for membership and to expedite the review and approval process, we ask that you complete the application form carefully and as thoroughly as possible. Admission to SPEE is based on peer review of your experience and achievements in petroleum evaluation. Therefore, the application requests a significant amount of information about your training and professional experience that will form the foundation for consideration of your membership in SPEE.

The following instructions are to help you in completing the application. If additional space is needed to answer any questions, please attach any necessary extra pages.

Page 2 - SPEE Sponsors and Sponsor Forms

SPEE requires endorsement of your membership by three Sponsors who are SPEE members and who are knowledgeable about your training and experience. It is preferable that these Sponsors have known you for more than one year and are already familiar with your record of technical evaluation experience through past contact and professional interaction. It is also preferable that Sponsors not all be from your current employer or firm, and we ask that no more than one be in a current subordinate position to you.

In the event that you cannot find three SPEE members who have known you for at least a year and who are already knowledgeable enough about your record of technical experience to comment as a Sponsor directly, you may be able to complete the sponsor requirement by locating SPEE members who are willing to meet with you to (1) discuss in detail your prior record of experience, (2) examine evidence of your prior technical evaluation work, and (3) be able to judge and attest to your qualifications for SPEE membership. Each SPEE Sponsor has latitude in how they conduct these meetings, discussions, and evaluations; however, please be aware that all applications for SPEE membership are subject to screening of the Qualifications Committee and approval of the Executive Committee. If Sponsor forms are deemed insufficient to provide attestation of your training and experience, then additional information from you or your SPEE Sponsors may be requested before a final decision regarding membership approval is rendered. As such, it is recommended that the Chairman of the Qualifications Committee be notified in advance if an applicant intends to apply for membership using an SPEE Sponsor who will provide sponsor attestation by the interview process, rather than based on prior knowledge of the applicant and his/her history of experience.

Blank Sponsor Forms are provided as separate documents, though the applicant is expected to be familiar with them. Each SPEE member who agrees to be your Sponsor is expected to fill out a Sponsor Form and submit the completed form directly to the SPEE office. You may enlist more than three Sponsors; however, SPEE is more concerned with the quality of information provided by each Sponsor, rather than in the number of Sponsors.

Page 2 - Additional References

These references should be selected to reinforce the sponsor endorsements and, if possible, illuminate areas of your experience not covered by the Sponsors.

Page 3 - Personal Information

This information is <u>not required</u>. The purpose for including this section is to provide information for the Membership Directory. You may elect to provide this information along with a photo (also optional) later.

Page 3 - Licensure or Professional Registration

This section is very important and should be filled out carefully and as fully as possible. SPEE encourages members to obtain professional licensure or registration. However, SPEE also recognizes that the form of, and criteria for, registration vary from place to place and that requirements have changed over time. SPEE further recognizes that the laws governing professional practice in the jurisdiction in which the candidate works may or may not require that a candidate be registered. The information that you provide in this section will be used to determine if you fall under the license and/or Registration provisions of the By-Laws. Answering these questions may require some research on your part. Most of the information regarding state laws is available on the Internet on the various state and province websites.

The third question asks for a citation to the law or regulation which governs registration in your location. SPEE is familiar with the regulations of most major oil states and provinces, however, if you think it would be useful; please attach a copy of the pertinent language to your application.

Page 5 - Record of Experience

SPEE requires that Full Member applicants have "ten years' experience in the evaluation of oil and gas properties." "Evaluation" of oil and gas properties includes, but is not limited to, the responsible determination of petroleum reserve/resources estimates, the responsible determination of production forecasts, and the responsible inclusion of the economic impacts of reserves/resources and production estimates. It is therefore important that your record of experience include sufficient definition of the type of work you have done and the time period in which it was done to allow reviewers to determine that you meet that requirement.

Page 5 - Specific Experience

This section requests a detailed discussion of four specific evaluation "projects" in which you personally did the evaluation work or contributed specific portions of the project evaluation. The purpose is to provide a gauge of your expertise in evaluation work. As used here "project" has a broad connotation regarding time and activities. Where you have a choice, recent work may be more useful than older work. Please provide as much detail as possible, but do not divulge confidential or client information. These project descriptions are a critical part of our evaluation to give us confidence that you spent the required time doing property evaluations. Be concise, be specific, be relevant, be clear about what you did yourself and what you supervised.
