

President's Letter

Wow! Isn't it great once again to be a part of a dynamic growth industry? Activities are up in almost every measurable category. There are more wells being drilled, more rigs running, more exploration being done, more properties being traded, more money being borrowed and spent, and more students enrolling in geology and petroleum engineering. After a decade of doldrums, it is back to "let the good times roll."

The above paragraph was written for my annual review for the World Oil magazine, but I feel it is appropriate for this quarter's news letter. The following comments will bring the membership current on SPEE topics of interest.

Monograph 1

The Society owes Brian Ausburn a sincere vote of appreciation. He has submitted a draft of the update of Monograph 1 to the SPE Reserves Definition Committee, with copies to the Executive Committee of the SPEE. Although there may be some 12th hour modifications, I am sure they will not be major in scope. Brian and I have both been discussing the publication options available to the Society, and are continuing discussions with the SPE who published the first edition. I expect that a plan of action for publishing the new edition will be in place by the end of the year.

Survey

I am extremely pleased to report that a most amicable meeting between the Executive Committee and Dr. Les Nemeth has resulted in clearing any misunderstandings about the copyrighting of the annual surveys of economic parameters. I personally wish to thank Dr. Nemeth for his long service to the Society and his guidance and assistance in the preparation of past surveys. On behalf of the Society I want to express my appreciation to Dr. Nemeth for his assistance in unifying the ownership of the parameter survey copyrights to the SPEE.

Amendments

Amendments one and two to the By-Laws are "house-keeping" amendments required to correct typographical errors. They overwhelmingly passed. Surprisingly enough, there were a few negative votes for even correcting the

spelling of the word "Canons" from the erroneous "Cannons" originally in the By-Laws. We are a group of original thinkers.

Amendment three, the notification that the SPEE has not adopted a specific set of reserve definitions but recommends that a report include a full disclosure of what definitions were used, also passed easily.

Amendment four, proposing the establishing of an Associate Member classification was defeated by a margin of 102 to 76.

I hope that in the near future some acceptable method will be found for including good qualified people in the SPEE, even though for some reason they are not registered.

Past Presidents Council

Under the leadership of Arlen Edgar, the Council of Past Presidents has developed into a true leadership position in the SPEE. The Council is not only offering advice on current topics of significance, but is studying and bringing to the attention of the Executive Committee and the Board of Directors issues which will become increasingly important in the near future. This group of past Society leaders is a wealth of talent from which we will continue to benefit.

Membership

The current membership remains at 495.

I am advised that the new membership directory will be available for distribution about Nov. 1. We have Ray Garcia and B.K. Buongiorno to thank for this fine effort.


SIPES ANNUAL SOCIAL
