

News You Can Use from Your Internet Committee

The Internet Committee is comprised of SPEE members Mike White and Jennifer Fitzgerald. In this article series of News You can Use, the Internet Committee, IC for short, covers useful aspects of your SPEE website. The address of the SPEE website is www.spee.org.



There is a new main menu item on the home page called **Login Help**. All previous login tips published in these various articles and more are available with a single click just when you need it most. It essentially outlines what things you can do on your own to reset a password versus when and how to seek assistance from a web administrator.

After logging in, check out the online membership directory. Online, an SPEE member may look up contact information on a fellow member. The online layout format is very similar to the hardcopy membership directory published last year with



one major advantage over the book form; the information is live and as current as a mouse click.

A login is required to view the directory and only SPEE members have rights to log in. In fact, when you login to the SPEE site, which often times is referred to as "logging into the directory," you are actually logging in to a view of your individual database record. While there, you can update any information if necessary. Operator buttons **Edit** and **Save** are located at the page bottom. So a scroll down may be necessary to see these buttons and to click on them.

Once done updating your own record, go to the main menu item **Membership**. Then on a sidebar menu off to the right, click on **Directory**. A screen of all members listed alphabetically by last name

appears. Each name contains hypertext. Select an individual, maybe even yourself, and view contact information in a

membership directory view similar to this screen shot. If a photo is on file, it will be displayed. Email addresses are hypertext as well. Should you desire to upload a photo (or change out a photo), simply email it to info@spee.org and it will be loaded. IC Committee at your service.

2015 SPEE Software Symposium Huge Success

On Thursday September 10, 2015, the SPEE and their industry partner QED Energy Associates held a Petroleum Evaluation Software Symposium at Anadarko's facilities in The Woodlands, Texas. Over 80 end users and vendors attended this event. The symposium focused on the capabilities and features of the various software packages and the direction of future development, both from the vendor's and the users' perspectives.

The methodology for this year's symposium differed from past symposiums in that separate surveys were sent to vendors and users as opposed to presenting the vendors with several problems to solve using their programs and the results being compared and contrasted. Twelve evaluation software development companies were sent surveys that questioned them about their software's capabilities, hardware and operating system requirements, unique features, and development directions. After the vendors' surveys were returned (11 of 12 companies chose to participate), the SPEE membership was sent an entirely different survey, with encouragement to pass it on to coworkers, including fellow engineers and engineering techs. This survey established what type company they work for, their job function, the end use of the evaluation software, which software package(s) they use, their experience with both the software and the vendor's customer service group, and the features that they would like to see added to that software. QED Energy Associates collected the submitted surveys and analyzed the results.

The morning session featured presentations from the 11 participating vendors, with emphasis on their software's unique features and the planned development direction. In the afternoon, Jennifer Fitzgerald (SPEE Director and Symposium Co-chairman) presented the results of the vendor's surveys and Courtney Stephens (CEO of QED Energy Associates) presented the results of the user's surveys. The symposium was concluded by a panel discussion focusing on the industry's desires for future development of evaluation software.

After expenses, the symposium earned over \$7,200 for the SPEE. Perspectives on the Fair Market Value of Oil and Gas Reserve/ Resource Ownership

In 2002 The Society of Petroleum Evaluation Engineers (SPEE) published the document titled *Perspectives on The Fair Market Value of Oil and Gas Interests*. Today it is commonly referred to as SPEE Monograph 2. A new SPEE Fair Market Value (FMV) Committee has been appointed with the task of updating the previous work. I was the editor and committee chairman during the original writing. I will be joined by Dee Patterson, this year's SPEE Vice President and destined to be next year's SPEE president, as co-chairman of the committee consisting of seven SPEE members. We are planning on expanding the example problem statements beyond the four used to solicit opinions of FMV as a part of the 2002 publication. The 2002 Monograph 2 has been used as an educational tool but I find its greatest value to be in the results of the SPEE member surveys that solicited opinions as to the FMV of the four hypothetical example problems mentioned above. The problems presented a general description of hypothetical properties and included economic projections (production and cash flow forecasts) similar to those of a typical reserve report. It is envisioned that an expanded set of example problems will be the primary focus of the updated work. Perhaps there will be some focus on unconventional reservoirs and/or quantities classed as a contingent resource.

As I recall, the responses to Example Problem No. 4, which presented both deterministic and probabilistic economic analyses to a hypothetical new field discovery, were very light. The original problem 4 included volumes classed as proved and unproved. Perhaps the industry experience gained in dealing with uncertainty during the period since that survey was taken will result in a better response rate to a similar problem.

The original surveys were confined to SPEE members and were sent one at a time by email over a period of several months with responses to each problem collected before distribution of the next problem in number order. I expect, when a new set of problems is developed, they will all be sent at the same time but that will be up to the committee. Whether you are an SPEE member or not, any ideas you have as to a problem statement will be welcome. If you are not an SPEE member but would like to participate in the FMV opinion surveys, let us know.

Opportunity Knocks?

Sometimes opportunities just fall into our laps.

A while ago, I was approached about a consulting job at a time when I really needed some work. A small startup firm was in the process of acquiring their first set of assets and one of the mezzanine financiers was looking for a quick assessment of the assets. It was in an area that I had worked and in which I had developed some expertise. As we discussed the project further, we discovered that I had participated in advising the purchaser in the first place, although the independent engineering report was prepared by others. Sometimes the things that fall into our laps are not really opportunities at all.

Using this fairly straightforward real-life scenario, I will offer a few thoughts on some screening processes that might help avoid ethical issues down the road. Although by no means an exhaustive treatment, it might be worthwhile to discuss a few issues related to qualifications, conflicts of interest, and independence.



Of course I am qualified – Aren't they offering to pay me?

In my scenario, qualifications were not an issue. The study the bank was requesting involved analyzing reservoirs with which I was familiar using techniques that I had used my entire career. Between SPEE's membership requirements and our members' average experience level, it is reasonable to think that we have amassed the experience needed to handle just about any assignment that might come our way. We also have enough experience to know what we do not know. The challenge is to put what we know to good use while we continue to develop our skills in new or changing areas. We need to avoid "cookie cutter engineering" and honestly assess our qualifications to perform the evaluation that is before us. I recall Scott Hickman at the SPEE Annual Meeting in 2012 suggesting that unconventional resources might be a separate area of expertise that might challenge our competency. At the risk of embarrassing him, if someone with Scott's skills and experience feels compelled to ask a question like that, then so should we on a regular basis.

Conflict of interest? Can't I take care of everyone, myself included?

The classic test for conflict of interest looks for a conflict between private interests and official responsibilities. This was no problem in my case. A second test for conflict of interest requires alignment between the interests of multiple clients. That was a problem, but not altogether insurmountable. I could imagine a scenario where my former client would grant permission for me to accept the assignment from the bank, although it was less likely that the bank would also accept. It is not enough to simply avoid conflicts of interest. One must always strive to avoid the appearance of conflicts of interest as well, and one mechanism for avoiding this appearance is full disclosure.

Do you really want me to grade my own work?

This brings us to our final point, independence. In my real-world scenario, assuming I could get by the other hurdles, it was simply not possible for me to advise one client and then develop an independent assessment for another on the same project. Those who work the sell side of transactions on a contingent fee basis are providing petroleum evaluation work that does not meet the test of independence since the evaluator's remuneration is dependent on the final valuation. Although the interests of the evaluator are aligned with the sellers, they are definitely not aligned with the purchasers. Nor would I suspect that reports prepared under this commercial model would be useful to lenders. Is this practice unethical? Not necessarily. But I would say it should be limited to transactions involving sophisticated counterparties, and the fact that the evaluation firm has a financial interest in the outcome should be disclosed.

In the end, our continuing ability to provide petroleum evaluations is conditioned upon the confidence that the users of our work can place in our ability and in our integrity. A little honest scrutiny at the beginning of an assignment along with a clear and open line of communication go a long way toward ensuring that our work continues to be of trustworthy and useful.
