On September 15th, the Dallas Chapter held its first meeting of the 2016-17 year. Dr. W. John Lee presented a talk entitled: Highlights from SPEE Monograph 4: Estimating Ultimate Recovery of Developed Wells in Low Permeability Reservoirs. The meeting was well received by approximately 80 attendees.

The next meeting was held on November 10th. The meeting was a joint meeting with the Dallas SPE chapter. Dr. Lance Kinney, executive director TBPE, presented an engineering ethics discussion.

Denver

On July 13th, Denver Chapter held its third quarter luncheon meeting of 2016 with 45 in attendance, 30 members and 15 guests. The speaker was Tim Wigley, President, Western Energy Alliance, speaking on the 2016 election cycle. Mr. Wigley

shared from his experience working in the Rocky Mountains with various energy companies and government agencies on promoting energy development and anti-fracking opposition. He spoke about an upcoming measure on the 2016 Colorado ballot if passed will change the citizen's initiative process for amending the Colorado state constitution. Currently, Colorado's constitution is among the easiest state constitutions in the U.S. to amend. It requires fewer signatures than any other state, only 98,492, to place a proposed amendment on the statewide ballot. As a result, Colorado has frequently attracted the attention of outside special interest groups who have attempted to use the citizen's initiative process to advance their cause. Since 2012, Colorado's oil and natural gas industry has been continuously fighting hostile ballot measures to ban fracking, place moratoriums on fracking, impose local control on energy development, and require expanded set-backs from wells, all largely driven by outside interests. The proposed change to the initiative process will require broader statewide appeal for proposed Constitutional amendments to make it to the ballot and supermajority of 55% votes cast to ratify rather than the current 50%+1.

On October 12th, Denver Chapter held its fourth quarter luncheon meeting with 38 in attendance, 28 members and nine guests. The speaker was David Ramsden-Wood, COO and Co-founder, OneEnergy Partners, speaking on, *Is* \$50 oil here to stay? Why the Permian has changed the Supply Equation. David shared that at \$50/BO there were potentially 125,000 locations throughout multiple benches in the Permian. He stressed that Permian-focused companies have greater access to retail capital to accelerate development than other North American basins. He pointed out that while oil production in most basins has fallen, strong well performance in the Permian has led to oil production growth for the basin with recent trends suggesting increased rig activity at \$50/BO.

Europe

SPEE European Chapter and SPE London Section jointly organised a continuing education seminar on Reserves & Resources Reporting, held at Geological Society, Burlington House, Piccadilly, London on 13th June. This is the first time the two sister societies have worked together in the UK. Despite the downturn in the UK oil and gas sector, the event was very well attended, with over 110 registrants; 40% operators, 25% contractors, 30% auditors, 5% bankers. The presenters came from resource audit companies and the UK banking sector,

covering topics from PRMS Update, COGEH, UNFC, investor due diligence, reserves-based lending, and case studies (using PRMS 2007, not the Draft Update). Bob Harrison, SPEE Europe Chair and OGRC member, presented an overview of the proposed changes to PRMS, and received the following (often impassioned) feedback from the seminar attendees.

- Poor communication from SPE; many of the London audience had no idea that PRMS was in the process of being updated, nor that they could contribute their feedback.
- Questionable transparency of the PRMS update process;
 OGRC sub-committee did not seek input from global SPE membership before commencing its work.
- Proposed changes to PRMS overly concerned with deterministic incremental methodology, and still do not reconcile deterministic with probabilistic categories.
- Lack of clear guidance on how to estimate chance of development.
- PRMS continues to use ambiguous language, when clearer, more appropriate wording is needed that corresponds to the intended probability.
- Proposed change to allow booking fuel gas as reserves will cause confusion and should be dropped.
- Serious misgivings over the proposed automatic upgrade of uneconomic 1C to 1P status, if the 2P estimate is judged to be commercial.
- OGRC's failure to merge PRMS with COGEH was declared to be an 'absolute disgrace.'
- PRMS should offer clear guidance on what is a reasonable confidence distance in unconventional resource assessments.
- Lack of guidance on how to better characterise offshore mature assets.
- PRMS still overly focused on subsurface rather than providing more granularity on production facilities, especially those facing decommissioning.
- North Sea fields often owned by consortia, so there are many CPRs on the same field, by different auditors, for different parties. The in-built flexibility in PRMS can lead to a field having different resource classifications existing at the same time. More prescription is needed.
- Disappointing lack of case studies to illustrate the principles of PRMS.

Overall, the seminar was a success, generating significant interest in the activities of the OGRC, and raising the profile of the SPEE in the region.

Unfortunately, the September meeting in at the offices of Beicip Franlab, Rueil-Malmaison, France, scheduled to include talks and a tour of IFP's laboratories, had to be cancelled due to economic pressure on attendance.

Chapter members are taking part in an initiative with the London financial sector and the SPE London Section to develop a template that specifies the content and format of Competent Person Reports to satisfy banker and investor criteria for fiscal modelling. The kick-off meeting was on 6th September to discuss the plausibility, content and requirements of such an "Investor Report," which will be PRMS-based as it is intended for the London Stock Exchange, but which has the potential to be used internationally, and to be extended to other resource reporting guidelines.

Regarding the European Chapter membership status; the Chapter has 36 members, and is still growing, albeit slowly, despite the current economic climate. Two new full member candidates will appear in this newsletter. There were 25 Expressions of Interest received after the SPEE/SPE CE seminar in June, but this surge of interest has not translated into a significant increase in applications, so reminders have been sent out to encourage interested parties to apply.

The final Chapter get-together of 2016, the AGM no less, will be held on 17th November at the offices of Lloyd's Register, 71 Fenchurch Street, London, EC3M 4BS, starting at 3pm. After the annual review, and a look ahead to 2017 and the eagerly anticipated Annual Meeting in London, new office bearers of the European Chapter Board will be proposed. The meeting will be rounded off with a talk by Victor Alcobia (Beicip Franlab) on Chemical EOR projects and their influence on PRMS application.

Houston

On Wednesday, September 7th, the chapter hosted Mr. Chuck Fox, CEO of Windy Cove Energy, to deliver our annual ethics hour program. Mr. Fox used ethics case studies to help attendees identify issues and highlight various parts of the engineering code. His presentation was capped by a discussion of the Citicorp Tower retrofit and the ethical manner in which its designer handled the retrofit of additional structural support. There were 64 members and guests present.

Dr. He Zhang, Ryder Scott Company, presented A New Empirical Analysis Technique for Shale Reservoirs on Wednesday, October 5th. This presentation shows work presented in SPE papers 175016 and 181536 which describe the Extended Exponential Decline Curve Analysis (EEDCA) technique, a method that uses an early and late time beta (β) to describe a non-constant hyperbolic b-factor. This method is contrasted with the use of the modified hyperbolic technique which assumes a constant b-factor and an exponential final decline, Dmin, to determine tight and shale well reserves. EEDCA is still being tested and is not being used by Ryder Scott for any reserve work at this time. We had 60 members and guests in attendance.

On Wednesday, November 2nd, Dr. Nathan Meehan, Baker Hughes and 2016 SPE President, presented *Sustainability and Risk to Global Resource*. In his talk, Dr. Meehan addressed several topics, one of which was that human development increases with the per capita increase in energy consumption. While we may not all agree on climate change, he showed that there are many energy issues on which we can agree. The conclusion: "Our purpose – safe affordable energy, improving people's lives." There were 51 members and guests in attendance.

Mr. Brent Hale, Cobb and Associates, will present Survey of Parameters Used in Property Evaluation on Tuesday, December 6th.

Mr. Steve Gardner, BBVA Compass Bank, will present Volumes and Value: How the Financial Sector Views Your Assets on Wednesday, January 4, 2017. This is our annual joint meeting with the SPE Gulf Coast Chapter Reservoir Study Group.

On Thursday, February 16, 2017, Mr. Dee Patterson, Moyes & Co., will make a presentation discussing the factors driving the LNG industry in North America and its effect on the world market. This is our annual joint meeting with SIPES.




THE ETHICS COLUMN

A Cautionary Tale

SEC FRAUD ACCUSATIONS: Geologist blames Breitling CEO

This headline appeared on the first page of the business section of the Dallas Morning News on July 1st of this year. The article written by Jeffrey Weiss details the story of a small oil company run amuck. The SEC complaint alleges that the companies owned and controlled by one man duped investors out of \$80 million, of which \$30 million was misappropriated to fund "a lifestyle of decadence and debauchery."

Named in the complaint is a professional geologist who acted as a petroleum evaluator. While the complaint does not allege that he took an active role in misappropriating funds, it does allege that his work was technically flawed, misrepresented as independent, and unilaterally



Flawed Methodology: Using the results of the best wells to estimate future performance.

The complaint alleges that the consultant selected only the best wells to use as analogs, and that his track record of assessing the performance of drilling prospects was very poor – in one case he predicted producing rates that were ten times the actual rates from the wells. This case is extreme, but when we look through our set of data for "comparable" wells do we take care to include and understand the poor performing wells? When we consider analog wells, do we simply assume that earlier, poorer performing wells are outliers? Consider the fairly common case where results in a resource play improve with time. Do we work to distinguish between the case where industry has developed completion techniques that result in higher recoveries from cases where with time industry has identified the sweet spots in a resource play? In the former, normalizing or neglecting the earlier wells may be appropriate while in the latter this could lead to a significant error.

Independence: Did the consultant have a stake in the outcome?

The complaint alleges that the reports were represented as independent assessments of the prospects, and yet the evaluator had signed documents as the Vice President of Exploration for the company. Clearly, in this case something should have been disclosed. That might very well have addressed this issue. There is a conflict of interest, or at least the appearance of one here. By not disclosing the actual relationship between the company and the evaluator potential investors were misled. Stating the obvious, independence is best achieved when the evaluator's remuneration does not in any way depend upon the reserves that are predicted.

Control of Work Product: The evaluator's report was unilaterally modified.

Sometimes, even cherry-picking the best wells was not good enough and so others changed the reports to inflate rates and reserves. The complaint alleges that the CEO of the company unilaterally increased the evaluator's estimates. This was clearly unethical of the CEO, but the question remains, how could he do that? In the end, we must first establish how our work is to be used and we must make sure that our work is used for the purposes intended. Perhaps, if the evaluator in question made it a constant practice to publish only complete, signed reports (as opposed to providing input to another's report) he could have better maintained control of the work product. It was his business to know how his reports were being used.

A Matter of Character: How long can one lie with dogs and not get fleas?

In the end, there is nothing to suggest that the evaluator participated in any of the excesses described in the complaint. It was his CEO who was spending millions on travel, clothes and nightclubs. In the end, even the evaluator's final paycheck bounced. But perhaps the he should have parted ways with his employers before it got to that. Now, his name is connected with the entire debacle and not just the parts for which he was responsible.

If someone from Hollywood had asked me for my opinion on this story, I would have told him that it was too farfetched. And yet here it is. I was relieved to learn that none of the named parties were SPEE Members, and with a little vigilance on your part none ever will.
