Gresident's Letter

reetings from the office of the President. November in Calgary came with an unusually cold blast of winter weather and snow, reminding us that winter has arrived and another reserves season is upon us. It's hard to believe that the end of the year is already approaching and my term is winding down. It has been an honor and a pleasure to serve the Society this year.

It has been a banner year for the Society. Our first Annual Conference outside of North America was very successful. We are now seeing membership applications from some of the European non-members who attended the conference. **Tim Gilblom** and the Qualifications Committee have been busy expeditiously processing new member applications throughout the year. Tim will be leaving the committee and **Neal Howard** will take over as the chair beginning January 1st. On behalf of the Society I extend thanks to Tim for his years of service on the committee. Thanks also to the rest of the committee who diligently take time to process applications in a timely manner.

The Asia-Pacific Chapter-in-Formation is progressing. Sufficient interest in formation of a Chapter has been expressed to indicate the minimum 10-person requirement for Chapter establishment will be easily be met. Individuals who will apply for membership and then form an interview panel for other member applicants have been identified and are in the process of preparing and submitting their membership applications. The Chapter will be based in Perth, Australia.

The amendments to the bylaws, which are proposed to change the grievance process, have been reviewed by the Council of Past Presidents and are now in the hands of the Board to final review and approval. After Board approval the revised bylaws will be available for membership review and comments and then will be put to a vote for membership approval in early 2018.

The Ethics Committee has reviewed and responded to comments from the Board on the update of the Ethics Guidelines, which were last updated in 2005. The revised draft document has again been reviewed by the Board of Directors and is back in the hands of the Ethics Committee to finalize. Thanks to **Tom Collier** and the rest of the Ethics Committee for their

hard work and patience to complete this muchneeded update of the Ethics Guidelines.

The Reserves Definition Committee has been working along with the sponsoring sister societies SPE/ WPC/AAPG/SEG



toward an updated version of the PRMS document, which was last published in 2007. The comment period on the proposed update draft of PRMS ended November 14. The RDC and selected Board members reviewed the updated document again during the review period. The SPE will construct a final draft and then seek the official response and approval from the sister societies, including SPEE. I extend thanks on behalf of the Society to Rod Sidle and the other members of the RDC for their hard work in reviewing this update and striving to ensure all changes are consistent with SPEE resource definitions.

The Calgary Chapter is progressing with the update of COGEH. The document is currently being reviewed internally by the COGEH Update Committee, chaired by **Doug Wright.** The Chapter is committed to issuing the update in Q1 2018.

Joe Young was very busy during his first year as Chair of the Training Committee. Joe coordinated seven Mono 4 training courses throughout the year. During the last half of the year Mono 4 classes were held in in Dallas (in-house at Pioneer's Office), Calgary, Oklahoma City, and Pittsburgh/ Southpointe. Thanks to SPEE members in the host chapters who assisted with the courses; Brenda Brown in Dallas, Mike Verney and the Calgary Chapter, and David Yard and the OKC Chapter, and Chuck Boyer in Pittsburgh. Course materials and monographs could not be shipped from Houston for the OKC course due to Hurricane Harvey. On July 27, the Denver Chapter held its third quarter luncheon meeting of 2017 with 44 in attendance, 27 members and 17 guests. The speaker was SPEE member Randy Freeborn, Chief Research Engineer with 3esi Enersight, speaking on

Production Rate Scaling Principles for use in Type Well. Randy discussed a new technique for scaling historical production data to reflect what a well might have done with different design parameters, including the number of fractures, completed well length, effective permeability, and others. Among other uses, the technique has the potential to increase the sample size of one's analogy set when constructing a type well profile.

Attendees enjoyed a selection of local microbrew beers, tasty appetizers, and unlimited games of ping pong, cornhole, and putt-putt golf.

The event was a combined member celebration and SPEE recruiting event and provided a great opportunity to introduce SPEE membership to qualified engineers and geologists in the Denver oil and gas community. We look forward to receiving membership applications and receiving new members to the Denver chapter in the coming months. What's planned for 2018? Stay tuned and find out!

On October 20, the Denver Chapter held its fourth quarter luncheon meeting of 2017 with 82 in attendance - 34 members and 48 guests. The speaker was SPEE member Creties Jenkins, Partner with Rose and Associates, LLP, speaking on Appraising and Developing Your Unconventionals: How to Avoid Squandering Billions of Dollars Next Time. Creties contrasted a rapid-drilling development approach that resulted in squandering billions of dollars with a staged approach that allowed companies to exit uneconomic plays before spending huge amounts of capital. He presented techniques to explore for and identify "sweet spots" in resource plays and presented a novel way to determine if a company's actual drilling results are better or worse than their a priori distribution of expected results.

One example of not appreciating the impact of uncertainty occurred in the Denver Basin. Three very similar wells (P10/P90 =2) were drilled early on and the future development was based on those wells. After 59 more wells were drilled, the P10/P90 ratio was 7.4 and the three early wells were found to all be P10 wells.

The staged evaluation process he advocates increases the chance that companies will avoid the common mistakes of focusing on production attainment instead of value creation and incorrectly thinking that enough was understood about a given reservoir to push ahead with development.

Europe

The Europe Chapter held a meeting on September 7 with presentations comparing various reserves reporting standards. The first presentation by Paul Taylor covered the differences between PRMS, NI51-101 and SEC. Each reserves standard has a slightly different purpose with the SEC and NI51-10 meant for securities reporting and PRMS geared more towards portfolio management. However, as PRMS is also accepted by some stock exchanges (e.g. UK, Australia, Singapore, Hong Kong) a comparison with the other standards is still meaningful. Some of the topics covered included pricing and costs, development intent and timing, project financing, split conditions across reserves categories, commerciality versus economic producibility and the handling of hydrocarbons consumed in operations. The second presentation by Dom Salacz covered the Chinese and Russian reserves standards. Under these standards the term "reserves" does not translate easily and it also refers to volumes in place (e.g. "geological reserves"). The Russian system is volume based rather than project based with categorizes dependent on maturity. The Chinese system has three main reserves classes: inferred-possible; indicatedprobable; and measured-proved. The Chinese terminology has nothing to do with the proved, probable and possible classifications in for example PRMS. Both presentations can be downloaded from the SPEE past presentations.

The final meeting, also serving as the chapter AGM, is planned for November 30.

Houston

Wednesday, September 6, the Houston chapter held their monthly luncheon. Devin Hahn and Sean Davis, attorneys with Winstead PC discussed recent energy restructurings and the general route that these companies pursued in bankruptcy. They related important new precedent resulting from these cases, and how this down-cycle will affect business going forward.

Wednesday, October 4, Dean Rietz, President of Ryder Scott Petroleum Consultants, spoke at the Houston chapter monthly luncheon. He highlighted important facets to consider when applying numerical simulation methods to use, or to augment oil and gas reserve estimates. The main 'take away' was appreciation of focus areas to arrive at meaningful estimates of oil and gas reserves that are based on reservoir models.

Wednesday, November 1, Cheng Zhang, a Business Development Executive, spoke at the Houston chapter monthly luncheon. He presented significant challenges encountered during the stochastic sampling process in stochastic reserve estimation. The focus was mitigating human bias, by showing methods that can be used to optimize and fit a distribution to raw reservoir data.



THE ETHICS COLUMN

Disagreement And Ethical Issues – Where Is The Line?

At what point does a difference in professional opinion become a matter of ethics?

Many, if not most of us, have experienced occasions in which others have asked us to reach a conclusion that was more favorable to them. Reflecting back on my professional experiences with several firms, I can recall the many times that I have entered into discussions in which I was asked to be "more reasonable" – in which "reasonable" was used in place of the word "optimistic." I can recall times in my professional experience in which I have advocated for higher estimates. One weekend just before a go / no-go decision was required for an acquisition, I received a call from one of my teammates asking if I could come to the office and look over his work on a project that our whole team was excited to pursue. We conferred for about two hours. I pushed him to find a



way that the project might work, but he convinced me in the end that he was right. What had initially appeared as a sound technical basis for the acquisition did not hold up under scrutiny. The two of us then worked to convince the remaining team members, ultimately deciding not to bid. To this day the area has not been developed.

We have professional disagreements on a regular and ongoing basis. These disagreements, or rather the additional introspection that arises from these disagreements, are a key component of the exploration and production process. In many cases they help us test and refine our analyses. They challenge us to explore multiple hypotheses and work to rapidly improve our assessments until we converge on a sound technical interpretation and range of possible outcomes.

While these exchanges are generally productive and to be encouraged, they can and do reach a point where ethical lapses can occur. These ethical lapses are relatively easy to describe, but difficult to identify in real life. I would submit that the distinction that separates ethical from unethical behavior on this point is one of intent. If the parties to the discussion are truly seeking the truth, then there is little likelihood of crossing into unethical territory. If any party to a discussion is advocating a position as a means to some other end then the likelihood of acting unethically grows. The proper estimation and classification of a hydrocarbon accumulation is independent of its financial attractiveness. To quote an unnamed modern philosopher, "It is what it is." Arguing for increased estimates or less risky reserve classification on the basis that truly analogous well performance supports a larger estimate and that current industry and/or regulatory practice supports a less risky reserve category is ethically sound. Making the same argument in order to secure corporate approval or external funding is a step on a very slippery moral slope.

How then, are we to distinguish when advocacy is in fact a breach of ethical behavior? The conversations in both cases may be so similar that it simply may not be possible to make such an assessment on a case-by-case basis, but over time we can observe patterns of behavior that will give us much more insight. All else equal, a diligent effort to seek the truth will come closer to the truth than a diligent effort to create an analysis that supports a desired course of action. In the end, ethical performance should lead to consistently more reliable analyses. These patterns of behavior establish our reputation as petroleum evaluators. The reputation for consistent, reliable work is one of the best indicators of consistent ethical performance, and should be jealously guarded.

Another way to distinguish unethical behavior is whether the means used to persuade others are based in fact or on coercion. Using my earlier example of the weekend meeting where we decided not to bid, my teammate made his case with the facts and pointed out very clearly how the facts supported his conclusion. From almost every standpoint – technically and ethically – he did exactly the right thing for all the right reasons. My teammate presented the facts clearly and forcefully, but in the end he allowed the facts to inform my opinion. There are other conversations that are ethically suspect and certainly any that contain a "my way or the highway" theme fall into the unethical category. Although it is not necessarily unethical to select third-party reserve evaluators (either internal or external) based on how well their work fits the situation, nor is it necessarily unethical to "shop for experts" in preparing expert witness testimony, it is just as unethical to use enticements or punishments to influence the work of the petroleum evaluator that has been selected as it is for the petroleum evaluator to perform work that is tailored to fit the preconceived opinions of client or management.

So at what point, then, does a difference of professional opinion become a matter of ethics? I would say that any time a party to the disagreement diverges from seeking the truth or attempts to coerce another party has begun to travel a potentially unethical course. And the truth has an amazing way of making itself known.
