Asia Pacific

We sincerely thank the members of SPEE for their ongoing support in making this a reality.

In addition, the AP Chapter chairman, Peter Stephenson, has recently been appointed a co-chair at the upcoming SPE Workshop: Reserves and Resources Estimation 24–25 July 2019 in Perth, Australia, and the AP Chapter has been in touch with the SPEE Monograph 5 committee to present an update on SPEE Monograph at the workshop to raise the SPEE profile in Asia Pacific, noting we have regulators from Indonesia (BP Migas) and Australia (ASX) present.

Ms. Coombs discussed, among other topics, how US demand growth is geographically concentrated on the Gulf of Mexico as LNG facilities begin commissioning and commercial service. On April 10, the Denver Chapter held its second luncheon meeting of 2019 with 79 in attendance - 30 members and 49 guests. The speaker was Mr. Chris Wright, CEO and Chairman of Liberty Oilfield Services, speaking on The Intimate Link between Health and Hydrocarbons. Chris asserted that the world's most lethal pollutant is particulate matter which is concentrated mostly in poorer nations whose inhabitants continue to burn biomass for fuel. The last 200 years have seen unparalleled progress in the human condition with life expectancy doubling from 35 to 72 years accomplished by wealthier nations shifting their energy sourcing from biofuels to hydrocarbon-based fuels. Over the last 25 years, 130,000 people per day have been lifted from extreme poverty. Further human progress is now facing new headwinds from a myopic focus on climate change and a "renewables-only" push by IMF, WHO and "generous" western governments. Chris further postulated that western governments in efforts to reduce greenhouse gas emissions should not limit people's energy choices as doing so will keep more people in poverty and will harm the environment far more than climate change. Rather, empower people now with cheap and abundant energy to save lives, forests, air quality, and water quality.

Europe

Overview

The European Chapter is now into its 10th year after being given full chapter status in January 2010. The present chapter officers were elected at the Europe Chapter annual general meeting (AGM) held in during the last 2018 meeting.

Chapter meeting

The Europe Chapter has held the first meeting of the year in London at the October's Gallery on Thursday the 28th of March. The meeting gathered about 16 members and non-members in London plus three people joining through Skype. Tom Gunningham (Rockflow) kindly accepted to be our speaker for the night and provided a great presentation titled: SEC Correspondence: A Minefield of Information.

Tom provided a brief background of the SEC as an institution. He explained who are actually the "rule makers" and the (very few) Petroleum Engineers working behind the scene. The purpose of the talk was not to discuss the actual SEC rules. The key links to relevant websites were provided, such as:

- Code of federal regulation, for the relevant S-X rules
- Modernization of O&G reporting documents
- Information about Compliance and Disclosure interpretations

The key points discussed were: (i) Who is actually concerned by the SEC? (ii) What can actually trigger an investigation? And, (iii) What are information is available for companies concerned about reserves evaluation under the SEC???

The two main search engines used to screen SEC comments letter are usually EDGAR (from the SEC) or the SEC Seeker from Ryder Scott. While it is important to note that those letters are only provided for information (ref SEC website), they still provide a valuable guidance for the evaluators.

The examples discussed during our meeting were:

- Miller Energy 2016
- Penn West Petroleum 2018
- Norstra Energy Inc 2015
- Centor Energy Inc 2018

Before closing the meeting, a case study was submitted for discussion to the attendees. The example was based on the case presented at the SPE PRMS workshop in Abu Dhabi in February 2019. The original file was provided by Danilo Bandiziol (courtesy of Bernard Seiller and Xavier Trussaut, Total) and the conversation focused on the maturation axis, and the conditions required to "upgrade" Contingent Resources to Reserves in specific cases: development plan, infill wells, water injection & EOR scheme.



Qualifications Committee

"We are from the Qualifications Committee and we are here to help."

Acknowledging that this Ronald Reagan mis-quote is sometimes the experience of applicants and sponsors, we would like to dispel that notion with some explanations and recent data.

The Qualifications Committee (QC) is appointed by the Executive Committee to review applications, recommend action on those applications, and study/recommend changes in qualifications requirements. One example of recent changes is the implementation of the Interview Method of sponsorship, where applicants with minimal exposure to SPEE membership in their work experience can sit down with an SPEE member and explain their work history and demonstrate their qualifications. I believe this has led to an increase in membership among those who work in a production company situation or find themselves in a more remote location. If you attend an SPEE luncheon when an applicant asks you to help them in their application by being an interviewer, please take the time to do so. We are working with Membership to develop a guide for interviewers that should give you the tools to conduct an efficient interview.

We also understand that it sometimes seems as though the QC process takes a long time. In calendar year 2018 we received 36 new applications for full membership. The average time from when the Chair received the application to when it went out to the QC as a whole was 16 days. The average time for the top 80% of these applications was three days. Those that skewed the average up usually required additional detail from the sponsors, new sponsors if the detail could not be provided by the original sponsors or clean-up of mistakes by the applicant. The majority of those mistakes had to do with responses in the licensing requirements section of the application.

The internal QC process takes some time for the five of us to agree upon a recommendation to the Executive Committee and send that recommendation forward. The average response time was 21 days for all of the applications, and the quickest 80% averaged 14 days. Sometimes our vacation schedules and day jobs slow us down.

Overall, the QC process averages 37 days from receiving the applications to forwarding a recommendation. The quickest 80% of the applications average 17 days. Beyond the QC, the process involves Executive Committee review and final decision on each applicant, publication of names in the newsletter and a 30-day comment period, all of which adds some time. We are working to see how to make the entire timeline shorter, maintain the integrity of the process, and grow the qualified membership for years to come.

THE ETHICS COLUMN

Don't Leave the Annual Meeting Early!

We have a first-rate ethics talk in store for you at the 56th Annual SPEE Meeting at the Fairmont Chateau Lake Louise from June 8 -11. Andrea Kim is back by popular demand to present this year. Many will remember her talk at the Lake Tahoe Annual Meeting. What makes her viewpoint so valuable, is that where the typical ethical talk presents hypothetical situations involving ethical people, Ms. Kim's role as an attorney who is often tasked with "finding the money" puts her in direct contact with ethical behavior run amok. Rather than the typical "what would you do if..." talk, she takes on the "why, exactly, did you do that?" For those of you making your travel plans for the Annual Meeting, pay particular attention to the June 11th schedule and do not cut your time short. If you cannot find a way



to stay for the entire Tuesday session without traveling back on Wednesday, then by all means travel back on Wednesday. You will have the bonus of another night in the Canadian Rockies. You can thank me later.

That is a win-win. I am looking forward to seeing you there.

My Job Is to Lie - Your Job is to Catch Me

With Stanley Cup finals underway, a hockey analogy seems in order. Can we look at the interplay between asset owners and third parties as who is shooting and who is in goal. Or is it something different entirely?

"I never thought the third-party engineers would believe it. I certainly didn't when I presented it." This quote is from a long time ago, not quite when today's unconventionals were a muddy seashore, but back when oil wells traveled straight down and reservoirs had permeability. It was the response of an engineer to a question from senior management as to why a certain project appeared in an independent third-party report included in an asset sale data room but did not appear as part of that asset's proposed budget.

I use this not to impugn the integrity of any of the players in this little vignette, but to focus our attention on the subjects of responsibilities and communication between the owner's petroleum evaluator and the third-party petroleum evaluator. This vignette does, however, represent a breakdown in those communications.

As to responsibilities, both evaluators had similar remits. Both were tasked with preparing their assessment of the hydrocarbon potential for the asset. The principal difference was in their purposes. The owner's evaluator was principally to advise the owner on the value of the assets. The third-party report was to give prospective bidders a level of comfort and perhaps something with which to begin the financing process. Both parties in this vignette did exactly what they were charged to do.

Where this story invites improvement is in the communication dynamics between the owner's petroleum evaluator and the third-party petroleum evaluator. Recognizing that petroleum evaluators often reach different conclusions, the exchange between the two should be one of discussion and exploration of those differences. The owner's petroleum evaluator should be putting forth projects and estimates that they believe are correct. Similarly, the third-party petroleum evaluator should do likewise and providing a report that reflects their view of the assets and not simply a reduction applied to the owner's assessment.

My illustration is from bygone days, and the comment was from an exasperated engineer attempting to steer budget funds into projects they felt were less risky. My last experience with this dynamic, although not as severe, is much more recent. Returning to my hockey analogy, are we in shooting on goal against the third party or are we passing the puck between us to get the best shot?
